Terms and Conditions

INTRODUCTION

TERMS OF SERVICE

The Service is owned and operated by DailyLangs (collectively referred to as "DailyLangs", "we", "us" or "our" in this document) is an Individual Entrepreneur (IE), IE ARRIETA VILLALBA OSCAR ANDRES, registered in Russia with taxpayer identification number 971801166432 and with its registered address at City Place Moscow, Russia. St. Pogonnyy Proyezd, 5.

ACCEPTANCE OF TERMS

- 1. DailyLangs provides its service (the "Service") to you, subject to the following Terms of Service.
- 2. By accessing or using the Service, you ("you") confirm that you agree to be bound by these Terms of Service. You also confirm that you are either at least 18 years old or, if you are younger than 18, that you have the permission of your parent or legal guardian, who will take responsibility for your compliance with these Terms of Service.
- 3. These Terms of Service may be updated from time to time by DailyLangs. You can review the most current version of the Terms of Service at any time here: https://dailylangs.com/terms.pdf Your continued use of the Service after any such changes have been made constitutes your acceptance of the new Terms of Service.

4. If you do not agree to comply with these or any future Terms of Service, do not use or access (or continue to use or access) the Service.

II. DESCRIPTION OF SERVICE

- The Service allows users that register for an account on the Service (each a "User") to create and update an online profile on the Service platforms ("Profile").
